

LICENSE AGREEMENT FOR
NSI XML RETAIL ACCOUNTING REPORTS
VALIDATION TOOLKIT

Issue 1.0 - May 8, 2007

This license agreement is in respect of the compilation of three (3) components relating to the NSI XML Retail Accounting Reports Technical Standard ("the Standard"), made available together by The Open Group under the title "the NSI XML Retail Accounting Reports Validation Toolkit", as well as the individual components thereof ("the Toolkit"), as revised from time to time.

YOU MUST NOT USE THIS TOOLKIT UNTIL YOU HAVE CAREFULLY READ AND AGREED TO THE FOLLOWING TERMS AND CONDITIONS. BY CLICKING ON THE "I ACCEPT" BUTTON BELOW YOU ARE CONSENTING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, CLICK THE "DO NOT ACCEPT" BUTTON. For the avoidance of doubt, this License does **not** authorize you to republish or distribute the Toolkit (nor any part of it), nor to create a report from the Toolkit ready for entry into an accounting system via a manual process.
