1. LICENSE

Subject to the terms of this License Agreement ("this License"), for and in consideration of membership in good standing of The Open Group ArchiMate Forum or, in the case of non-members payment of the applicable annual license fee stipulated above, The Open Group grants the above named Organization ("the Licensee") a non-exclusive license for any purpose (including use for commercial gain) to use and implement The Open Group ArchiMate® standard found in the associated documentation suite known as ArchiMate® 3.0 Specification, and all its earlier versions, ("the Documentation"), provided that:

- A. The Licensee has paid the annual license fee relating to commercial use of ArchiMate 3.0 Specification;
- B. All existing copyright and trademark notices are retained in all copies or extracts of the Documentation; and,
- C. All existing copyright and trademark notices and this License appear in all supporting documentation.

The following conditions apply to the use of the Documentation:

1.1 COMMERCIAL USE
